## Terms and conditions of Repair and Maintenance of ACs

- 1. Agency agrees to provide quality services mentioned in the contract
- 2. During the contract the Agency will provide one wet service and two dry services.
- 3. The Agency will attend the break down call as and when required by the Corporation. (OMBADC).
- 4. Re-installation, electrical supply, control panel and stabilizer are not covered under the contract.
- 5. Before entering into AMC all ACs should be checked by the Agency.
- 6. Gas charging (filling), Suction line, Capillary, Strainer, Blower Motor, outdoor motor, PCB, Swing motor, Capacitor and Functional Parts Condenser, cooling coil, Main PCB, display pcb, Thermistor covered under AMC.
- 7. In case the selected agency would like to leave the contract agreement for any reason, he shall give, at least, two-month notice to the OMBADC in advance.
- 8. If any misconduct on the part of the selected agency is observed, after an enquiry, the OMBADC on its discretion may terminate the services of the agency, without notice.
- 9. The agreement/ contract period shall stand terminated automatically on expiry of the stipulated period, (One Year), if not extended prior to the stipulated date and the Second Party shall not be entitled to any claim for service rendered after expiry of the stipulated date of contract.
